



COVID-19 Vaccination Policy

Effective December 20, 2021, students, contractors, and visitors will be required to show government issued photo ID and proof of vaccination to access all ESC facilities. ESC will also accept a negative COVID-19 test result within 72 hours, prior to accessing an ESC facility.

Regardless of vaccination status, all safeguards, including daily health screening, physical distancing and face masks will remain in place.

H₂S Alive[®] Blended Renewal Course

The <u>course</u> includes online theory, followed by a skills assessment through an Authorized Training Partner (ATP). The prerequisite is a current valid H_2S Alive® certificate.

Employers can become an ATP with Internal Assessors for the <u>H₂S Alive[®] Blended</u> Renewal Course. Requirements include:

- ATP Application and fees
- Assessor training and maintenance cycle
- · Purchasing of online theory and certificate packages

Know the Law

<u>Changes to Alberta Occupational Health and Safety (OHS) laws</u> come into effect December 1. Employers are responsible for reviewing the changes and making any necessary revisions to their programs.

Stakeholder Survey Results

A stakeholder survey was conducted from October to November to track ESC's performance and understand how its brand and reputation have evolved. The survey drew over 400 responses, an increase of 25% over 2020 participation. Ratings of ESC's performance remain strong with 90% agreeing that ESC has a meaningful impact on making industry safer and 87% of respondents stating ESC has contributed to an increase in their skills and knowledge that can be applied on the job.

KEY INITIATIVES

Certificate of Recognition (COR) Program

The <u>2022 COVID-19 Auditing Requirements</u> were reviewed in a <u>recorded session</u> on October 28. Key points include:

- Alberta document only audits no longer available after January 1, 2022
- No observations permitted until March 31, 2022
- No changes to auditing requirements in BC

The Well Service Blowout Prevention Course

The course is being updated to create a blended program with updated content to better reflect current industry needs.

CAOEC (formerly CAODC) Service Rig Assessor

ESC will provide confirmation of completion for the CAODC (CAOEC) Service Rig Competency Assessors course on a worker's Record of Training. Valid CAODC Rig Assessor Competency certificates will continue to be recognized and will be available as a Record of Training.

Safety Centre of Excellence

Dr. Tristan Casey shared his award-winning LEAD model in October. Author Brent Sutton presented in November. Brent is co-author of 'The Practice of Learning Teams' and recently released a White Paper- Learning From Everyday Work.

Drilling & Completions Committee (DACC)

IRP 2: Completing and Servicing Sour Wells

IRP 2 is available for a final 30-day industry review, ending December 2.

IRP 27: Wellbore Decommissioning

Industry feedback from April has been incorporated into IRP 27. The committee will be asking for DACC approval to proceed with their final industry review at the November 17 meeting.

IRP 28: Drilling and Completions Waste Management

IRP 28 is available for a final 30-day industry review, ending December 2.

IRP 29: Temporary Pipework, Securement and Restraint

Committee members are collaborating with C-FER Technologies to determine the loads and energy produced during the failure of temporary piping. This will allow for additional guidance when designing a temporary pipe restraint system.

IRP 30: Temporary Wellbore Suspension

The CAPP scoping document was reviewed at the November 9 meeting. The committee will meet on December 14 to draft a content outline.
