### Safety Management and Regulatory Awareness for Wellsite Supervision (SARA) Refresher Program Certificate Extension

The program was discontinued at the end of December 2020. To ensure a smooth transition for workers, existing SARA certificates expiring between January 1, 2021 - April 30, 2021 were automatically extended for 120 days. The change will assist workers seeking IRP 7 compliant supervisor training particularly as the current drilling season winds down.

# KEY PROJECTS

### **Process Safety Program**

ESC's <u>Process Safety Program</u> now includes several posters to build awareness and prompt process safety discussion in the workplace.

### Human and Organizational Performance (HOP) Community of Practice (COP)

The second meeting was held March 4 where three companies presented their journey into HOP and Safety Differently. 'Save the Date' for the April 7 COP as John Green, VP Global HSE, SNC-Lavalin Inc. will be speaking. Currently we have thirteen oil and gas companies taking part in the COP.

### **First Line Supervisors Blowout Prevention Certification**

Starting April 1, exam challenges will be offered for two consecutive recertification cycles for First Line Supervisors Blowout Prevention. The certification will remain valid for 3 years and the student must maintain a certification that is not expired by more than 30 days to qualify for the challenge.

# **Drilling & Completion Committee (DACC)**

### **IRP 2: Completing and Servicing Sour Wells**

IRP 2 has been completed and will be going out for industry review. Industry provides practices for the safe planning, equipment and fluid handling for completions and servicing operations on sour wells using a service rig. "Critical" has been removed from the title and the document was updated to define the sour requirements and additional needs based on release rate and proximity.

### **IRP 21: Coiled Tubing Operations**

IRP 21 review period ended on March 25.

### IRP 22: RMD/MPD/UBD Operations

IRP 22 has been sanctioned and is now available.

### **IRP 28: Drilling and Completions Waste Management**

IRP 28 has been completed and will be going out for industry review. Drilling and Completions Waste Management provides an overview of industry recommendations for waste management options for the oil and gas sector.

### **IRP 29: Temporary Flow Piping (New)**

The committee has formed four working groups addressing: dynamic forces, defining pipe, connections and components, safety zone and risk-based approaches.



### **Oil Sands**

Working On and Around Water and Ice Guideline is out for a 45-day industry review ending April 9, 2021; Initiatives include Driving in the Mine; Tailings Safety on Spill Boxes and Spill Pipes; Monthly Get a Grip teleconference; Alberta Prevention Initiative Slips, Trips & Falls Working Committee meeting.

### **British Columbia**

Safety presentations were delivered for the Ryder Logistics Group on Daylight Savings Time and Life Savings Rules. Q1 Advisory Committee Meeting took place. Meetings with prime contractors and the vac truck task group continue.

### Saskatchewan

Virtual meetings are now underway with surcharged employers.
