# **Highlights**

# **COVID-19 Update**

ESC has developed a phased re-entry plan and is taking a measured approach while following all provincial guidelines to create a safe environment for students and staff. In the first phase, a single classroom will be available at our Calgary and Nisku locations to offer critical classroom-delivery courses. Throughout all stages we will be:

- Conducting active daily screening questionnaire before classes begin.
- Increasing the frequency of cleaning and sanitizing.
- Sanitizing all classroom equipment.
- · Providing hand sanitizing stations throughout the building.
- Taking steps to allow for physical distancing of two metres throughout the building.
- Limiting the number of people in the classroom and the building.
- Strictly limiting use of the lunchroom area. Alternative options include outdoor tables and several restaurants nearby that offer take-out and drive-through service.
- Anyone who is feeling unwell will be asked to stay home and we will assist with re-scheduling their course.
